AN ORDER CREATING THE EXPANDED LOCAL POVERTY REDUCTION ACTION PLAN TEAM (LPRAT) OF THE MUNICIPALITY OF QUINAPONDAN, EASTERN SAMAR, ESTABLISHING ITS COMPOSITION AND FUNCTION THEREOF

WHEREAS, the National Government is pursuing the Millennium Development Goal of reducing poverty in the Philippines

WHEREAS, as a strategy to reduce poverty in an municipality, the Local Government Unit partnered with the DSWD through the KALAHI-CIDSS which makes planning budgeting and project implementation more participatory through the genuine involvement of the grassroots organizations and communities;

WHEREAS, such partnership entails the preparation of the Local Poverty Reduction Action Plan (LPRAT) which contains program and projects collectively drawn through a participatory process by the LGU with civil society organizations and other stakeholders, and which will directly address the needs of the poor constituencies and the marginalized sectors in the Local Government Unit;

WHEREAS, in the preparation of the LPRAP, the expanded Local Poverty Reduction Action Plan Team (LPRAT) has to be reconstituted and reactivated in order to spearhead the formulation and monitoring of LPRAT;

NOW THEREFORE, I Atty. Rafael S. Asebias, Municipal Mayor of Quinapondan, Eastern Samar, by virtue of the powers vested in me by the law do hereby order the creation of an expanded LPRAT which shall be composed of the following;



The Expanded Local Poverty Reduction Action Team shall have the following responsibilities:

- a. Conduct a workshop to formulate a Local Poverty Reduction Action Plan (LPRAT) based on a relevant sex- disaggregated economic, social, climate change vulnerability and adaption data, and gender mainstreaming;
- b. Identify the poverty reduction strategy to be undertaken by the Local Government Unit and other stakeholders, including national agencies;
- c. Identify gender – responsive results – based priority reduction projects to be funded by the Local Government Unit and those which will be submitted to national agencies.

This Executive Order shall take effect immediately.
